As there were only two participants this was a very informal meeting We reviewed the outstanding actions as follows:

An event connected with the Motspur Park station centenary (a picnic-in-the-park was suggested)
Events in conjunction with the Scouts

Notes of meeting with Fulham Foundation

held at Fulham training Ground at 1800 on Thursday 17th October 2024

Although Martin had written to Andrew Kaufman asking for some details about the rumoured Fulham proposals he received no reply and was not invited (until Anthony Hopkins prompted by John) Also the Residents' Association was not invited This shows that the Council's focus is entirely on sports and not the other uses of the playing fields

Mike McSweeney said that he represented the Fulham Foundation which is the charitable arm of Fulham Football Club

At the moment the Foundation has temporary accommodation for its staff and activities (in Worcester Park) and is looking for somewhere permanent

There are various options being explored but Sir Joseph Hood would be a good site due to its proximity to their other facilities

They have 50 staff but most are working remotely so the requirement is for a hub They also need facilities for autistic children (sensory room), somewhere dementia friendly, a classroom, coaching facilities etc

The total area would be about 2500 square feet

They emphasised that they were not looking to displace any current users of the site They said they hadn't got any plans drawn up (which was disingenuous as they did have plans for a new building but they didn't want to scare us by producing them)

They would have been happy to upgrade the Pavilion - but equally could create something new

They have some capital funds available for investment

They need a fairly quick decision (say 6 months)

Fulham have been talking to the Council for a year

They haven't got very far!

Anthony Hopkins was keen to get all the sporting groups on board

They generally were OK as long as the existing usage was continued

Hopkins was keen to instruct consultants to get to work on producing proposals It seemed as though he wanted to do this anyway and wasn't particularly linked to the Fulham suggestions

The Council have "becoming London's Borough of Sport" as a key strategic objective and it looks like they want to develop SJH.

Comments made:

Bernie: don't forget that the park is used by residents for many purposes not only sport Chris (caretaker) - flooding is an issue (various promises about that have not been kept) Sam: car parking is a big issue

My thoughts:

I felt that the Council were not going to respond quickly enough to make a deal with Fulham

It was very encouraging that investment funds were available and we should think carefully about what we might want from it

We need to try and get involved in the process (eg the remit to consultants) We need to get local people on board
